

August 5, 2018 thru August 11, 2018	Calls for Service 737	Residential Burglaries 1
Total Year to Date for 2018	20,653	41

For the period of Sunday, August 5, 2018, through Saturday, August 11, 2018, the Police Department responded to 737 calls for service. One residential burglary and no attempt residential burglaries occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.

Sunday, August 5, 2018
