

July 22, 2018 thru July 28, 2018	Calls for Service 696	Residential Burglaries 3
Total Year to Date for 2018	18,407	38

For the period of Sunday, July 22, 2018, through Saturday, July 28, 2018, the Police Department responded to 696 calls for service. Three residential burglaries and no attempt residential burglaries occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.

Sunday, July 22, 2018

Monday, July 23, 2018

6:27 A.M. - PROPERTY FOR SAFEKEEPING: S/Samantha Rasha (28), (Los Angeles, CA) was contacted on a bicycle stop. S/Rasha was on parole for PC 211. During the contact S/Rasha had a phone that had possible ID theft information (photos of ID cards/CDL's). S/Rasha claimed the phone belonged to her ex-boyfriend. Detectives were notified.

10:49 A.M. - FOUND PROPERTY / ORLANDO ROAD & ROSALIND ROAD: SMPD Officer was flagged down by a pedestrian in the area of Orlando Road and Cameron Road. The pedestrian, stated he found a driver's license and an AAA card. SMPD Officer took the license and AAA card as found property. A records check of S/Bautista determined his driver's license was suspended. S/Bautista was arrested and issued an O/R citation and released in the field. S/Bautista's vehicle was driven away by the passenger who had a valid license.

Tuesday, July 24, 2018

2:37 P.M. - APS REPORT / SUSPECTED ELDER FINANCIAL ABUSE / P.C. 530.5 / IDENTITY THEFT / 1700 BLOCK WINDSOR ROAD: SMPD received a fax from Los Angeles Workforce Development Aging and Community Services regarding a financial elder

abuse report. Officers went to the above location and contacted the victim. Unknown suspect(s) gained access to victim's on-line banking information and were able to send out checks from his bill pay service. The suspected elder financial abuse allegation was unfounded.

3:49 P.M. - 902T / NON-INJURY / TRAFFIC COLLISION / SAN MARINO AVENUE & STRATFORD ROAD: P1 collided into P2 at the above location.

Wednesday, July 25, 2018

3:50 A.M. - FOUND PROPERTY / 400 BLOCK HUNTINGTON DRIVE: SMPD Officers located a stroller with a bag of dirty clothing and trash and a broken Acer laptop. The stroller appeared to belong to a homeless person. A check of the area for someone who owned the property met with negative results. The laptop was entered into APS and the property was booked for safekeeping.

Victim stated she attempted to report the crime on Monday at a police station close to where her son lives in Thousand Oaks but was told to come to this department to file the report.

2:16 P.M. - P.C. 530.5 / IDENTITY THEFT / P.C. 484(g) / FRAUDULENT USE OF ACCESS CARD / 2200 BLOCK MELVILLE DRIVE: Victim came into the SMPD lobby to reference an identity theft report. Unknown suspect(s) used her Neiman Marcus credit card to make several purchases. Victim stated she is in possession of her Neiman Marcus credit card and has no idea who could have made these fraudulent transactions.

Thursday, July 26, 2018

2:10 A.M. - PROPERTY FOR DESTRUCTION / 2200 BLOCK HUNTINGTON DRIVE: Reporting party walked into the station to turn in a Beretta Pistol and ammunition for property for destruction. Both items were taken and properly labeled and secured into the evidence locker.

Victim stated he let an ex school mate stay with him for a few weeks. He then noticed several items missing from inside the house over a period of time. He made his school mate leave his residence after locating some of his property inside the room where school mate was staying. The investigation is ongoing.

3:50 P.M. - PC 530.5 / IDENTITY THEFT / 1900 BLOCK KERNS AVENUE: SMPD Officers were dispatched to the police lobby for an identity theft investigation. Victim stated unknown suspect(s) used her personal information to open a Chase credit card account. She realized the account was opened when she received an email from Chase saying her new card was on its way. She was able to cancel the card before any charges were made.

Friday, July 27, 2018

9:47 A.M. – PC 314 / INDECENT EXPOSURE / SAN MARINO & SHERWOOD: Victim called SMPD to report this incident at 0925hrs. Victim stated a male, white, approximately 6' tall, thin and muscular, got out of a white GMC truck with see-through shorts. He turned towards the victim and exposed himself. Victim stated she was offended and desired prosecution. However victim said she cannot identify the suspect.

10:02 P.M. - FOUND PROPERTY / ST. ALBANS & HUNTINGTON DRIVE: City Employee located a backpack in the area. The backpack contained miscellaneous clothing.

1:42 P.M. – PC 459 / RESIDENTIAL BURGLARY / 500 BLOCK SIERRA MADRE: SMPD Officers were dispatched to the location for an audible alarm covering the kitchen and living room motion. SMPD Officers arrived on scene and checked the property. The front door was found unlocked and officers made entry to search the interior. Officers located several rooms which appeared to be ransacked. The resident arrived on scene a short time later and confirmed the burglary. Unknown suspect(s) entered the residence by forcing open the kitchen window. Once inside, suspect(s) ransacked several rooms and removed a small safe from the master bedroom closet. It appears the unknown suspect(s) exited through the front door.

6:42 P.M. - PC 459 / RESIDENTIAL BURGLARY / 2700 BLOCK GAINSBOROUGH DRIVE: SMPD Officers were dispatched to the above location for an audible alarm covering the interior motion. SMPD Officer arrived on scene and checked the front of the property. SMPD Officer was not able to enter the rear yard. Most of the rear of the property could be seen however and nothing seemed to be disturbed. SMPD Officer could also see into the location and it did not appear anything was disturbed. SMPD Officer cleared the location. At 1759hrs, the resident called to report the burglary. SMPD Officers returned to the location and contacted the resident. It was determined the unknown suspects entered the location by jumping over the gate using the pool filter. They smashed the master bedroom slider and gained entry. Only the master bedroom was ransacked. The location has video cameras which shows two males enter the property on foot and walk up the driveway. Once in the rear yard, they used a nearby weight to smash the window and gained entry. Unknown suspects were covered with hooded sweatshirts, gloves and long pants. They appear to be male, African American, thin build. The alarm company waited 8 minutes before notifying the Department of the alarm.
