

<b>April 14, 2019 thru April 20, 2019</b>	<b>Calls for Service 517</b>	<b>Residential Burglaries 1</b>
<b>Total Year to Date for 2019</b>	<b>8,731</b>	<b>19</b>

For the period of Sunday, April 14, 2019, through Saturday, April 20, 2019, the Police Department responded to 517 calls for service. One residential burglary and No attempt residential burglaries occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.

**Sunday, April 14, 2019**

**12:39 P.M. - 901T / INJURY / TRAFFIC COLLISION / HUNTINGTON & WINSTON:** SMPD Officer was driving by the location and observed a vehicle on the center median. The driver was contacted and stated she lost control of her vehicle after another vehicle cut her off. She suffered minor abrasions from the airbag deployment. Her vehicle was towed.

**4:07 P.M. – PC 530.5 / IDENTITY THEFT /1700 BLOCK CHELSEA:** SMPD Officer assisted with an identity theft investigation. Unknown suspect(s) used victim’s personal information to make changes on his bank and credit card accounts. Victim was notified of the changes by Chase Bank and told them he did not authorize the changes. All the accounts were cancelled. No loss at this time.

**8:58 P.M. - INCIDENT REPORT / PROPERTY FOR SAFEKEEPING / HUNTINGTON & FLETCHER:** SMPD Officer was dispatched to the area of Huntington Drive and Granada Avenue reference a report of a reckless driver. SMPD Officer observed the vehicle and stopped it for a vehicle code violation. After the call was complete, SMPD Officer Observed property belonging to the driver, it was booked as safe keeping and it will be returned to the owner.

**Monday, April 15, 2019**

**3:54 P.M. – 902T / NON-INJURY / TRAFFIC COLLISION / SAN MARINO & LORAIN:** P1 and P2 were involved in a minor traffic collision at the intersection of San Marino and Lorain. P1 admitted to reaching down for a water bottle and failed to stop in time before colliding in to the rear of P2’s vehicle. Minor damage reported, both vehicles driven from scene.

**Tuesday, April 16, 2019**

**6:03 A.M. - 901T / INJURY / TRAFFIC COLLISION /LOS ROBLES & MISSION:** P1 and P2 were involved in a minor traffic collision in the intersection of Los Robles and Mission. P1 started to proceed through the intersection on the flashing red after stopping. The signal phased back to normal settings and P2 went through the intersection on a green light. Signal Repair and Park and PW Director were notified to check the intersection lighting. P1 was transported to a local hospital for complaint of pain to her leg and the right side of her head and neck.

**8:54 A.M. – 902T / NON-INJURY / ST. ALBANS & HUNTINGTON DRIVE:** P1 and P2 were involved in a minor traffic collision when P1 reached down to grab an item in his vehicle and rear ended P2. Both vehicles were driven from the scene.

**Wednesday, April 17, 2019**

**2:18 P.M. — WARRANT/ ARREST / HUNTINGTON DRIVE & MONTEREY ROAD:** SMPD Officers conducted a traffic stop on a vehicle with no plates. Driver was identified as S/Isaiah, Thibodeaux by his California DL. A records check showed S/Isaiah had an active warrant in the amount of \$5,000 from San Bernardino County. San Bernardino advised to cite out. S/Isaiah was issued an OR cite and released in the field.

**3:08 P.M. – PC 664/459 / RESIDENTIAL BURGLARY with ARREST / 2300 BLOCK ROBLES:** Victim called and stated she saw two male blacks wearing all black in her rear yard, through video surveillance. SMPD Officers arrived on scene and suspect vehicle started to pull away. A quick pursuit ensued and the driver (Harris Lew) yielded in the 1200 block of Sierra Madre and was taken into custody. A perimeter was set up and a door to door search was conducted for the other two suspects. A resident on Montecito had video of two suspects running westbound on Montecito prior to our perimeter being set up. S/Lew was transported to Alhambra jail for booking and housing for PC 664/459, VC 2800.1, and VC 14601.1.

**Thursday, April 18, 2019**

**1:06 P.M. - FOUND PROPERTY / 2100 BLOCK OAK KNOLL AVENUE:** A found property report was taken when a leather folder was found. It was originally thought to belong to the resident at above address. The resident was contacted and said the item did not belong to him. No owner information was located inside the folder. The property was booked into evidence.

**12:44 P.M. - PC 484 / PETTY THEFT / 1500 BLOCK WILSON AVENUE:** SMPD officers were dispatched to above location regarding work tools taken from a vehicle. SMPD Officers arrived on scene and conducted a search of the area for the suspect's vehicle which was described as a white Ford Bronco. Two males were seen (driver and front passenger) driving up to the victim's work truck. The front passenger exited the vehicle and removed tools from victim's vehicle. A nearby gardener witnessed what was going on and took a short video of the crime. A license plate from the vehicle was seen in the video. A registration check of the DMV system returned the plate to a 2001 Ford pick-up to a residence in Pomona. PDI was called to the area and was unable to locate the suspect vehicle. Detectives were notified.

**2:15 P.M. - FOUND PROPERTY / 1200 BLOCK ST. ALBANS ROAD:** A wallet containing miscellaneous credit card and ID was located. The owner was located and contacted, however they will not be able to retrieve the items for two weeks. The items were booked into evidence

**3:38 P.M. - PC 530.5 / IDENTITY THEFT / 2400 BLOCK CONISTON PLACE:** Victim received a phone call on 04/12/2019 from both Nordstrom's and Macy's wanting to verify if she had made purchases using her store credit cards. She told the stores that she not make purchases. She also discovered that her information was used to open a Victoria Secrets credit card and a Gordon's Jewelers credit application was submitted. The Victoria Secrets credit card was approved and the Gordon's Jewelers application was denied. A purchase on the victim's JCP Penney credit card transaction was attempted but denied.

**4:39 P.M. - PC 530.5 / IDENTITY THEFT / 2800 BLOCK SHEFFIELD ROAD:** Victim was looking through her husband's email and located a receipt dated 4/17/19 indicated purchases of two phones one in her name and the other in her husband's name. She contacted her husband and he confirmed that he did not purchase any cell phones. Victim contacted Verizon who cancelled the accounts and credited her the purchase price. Verizon also advised that the purchase occurred at their store in the Tustin Legacy (Tustin, CA). Also they advised her that ID is needed to purchase phones.

**7:49 P.M. - MISSING/LOCATE | EL MOLINO & PASQUALITO:** Missing person reported and was located by SMPD Officer's.

**7:12 P.M. FIRST AMENDMENT ACTIVITY | 1200 BLOCK PATTON COURT:** SMPD Officers were dispatched to the above location regarding approximately 30 people involved in a peaceful protest. SMPD Officer's arrived on scene and staged for additional units to arrive from surrounding agencies to assist. Two South Pasadena Officers arrived to assist. San Gabriel Police and Alhambra Police were diverted to handle other priority calls in the city. Officers made contact with the group and spoke with the organizer. The organizer was aware of the City ordinance regarding Targeted Residential Picketing. The group of protestors left the location at approximately 2000 hours on their own accord. The organizer advised there are future protests planned for the location, but did not provide any additional information.

**Friday, April 19, 2019**

**3:19 P.M. - PC 530.5 / IDENTITY THEFT / CVC 31 / PROVIDE FALSE INFO TO POLICE OFFICER / 2200 BLOCK HUNTINGTON DRIVE:** Victim came into the SMPD lobby to report the above. On 04/16/2019, he was notified by his employer that his license was suspended for a FTA on a traffic citation. He went to his local DMV office who sent him to the Pasadena Courthouse regarding the citation. He received a copy of the citation which was issued by this agency for CVC 4000(a)(1) and CVC 12951 on 09/10/2018. The driver (suspect) of the vehicle verbally provided the victim's name and California driver license number to the SMPD officer. Additionally after a want/warrant check conducted, two outstanding warrants were located from the El Monte Police Department. The victim went to the EMPD and checked on the warrants. The EMPD booking photos were not of the victim.

**CRI9-0335 - CVC 22651(o)(1)(a) / REGISTRATION EXPIRED OVER 6 MONTH / 2300 BLOCK HUNTINGTON DRIVE:** SMPD Cadet observed a vehicle in front of the location with "OCT 2018" registration tabs displayed on the rear license plate. The vehicle's registration was checked in the DMV system. The vehicle returned expired as of 10/14/2018. The vehicle was stored under CVC 22651(o)(1)(a).

**8:59 P.M. - INCIDENT REPORT / 500 BLOCK LA PAZ DRIVE:** RP contacted the San Marino Police Department advising of two male subjects yelling and screaming in a small white sedan in front of the above location. SMPD Officers arrived on scene for an investigation. It was determined no crime occurred and the incident was documented with a report and photographs.

**Saturday, April 20, 2019**

**11:51 A.M. - 902T / NON-INJURY / TRAFFIC COLLISION / SHERWOOD ROAD & SAN MARINO AVENUE:** P1 was stopped along the west curb with hazard lights on. P2 was traveling southbound on San Marino Avenue approaching the intersection with Sherwood Road. P1 accelerated

and merged into the southbound lane just as P2 was passing and struck P2's rear end. Both vehicles sustained minor damage were able to drive away from the location.

**2:16 P.M. - PC 459 / VEHICLE BURGLARY / 2000 BLOCK HUNTINGTON DRIVE:** Unknown suspect(s) smashed the driver side window and took a backpack containing victim's purse. Unknown suspect(s) made charges at Target. Victim received text messages on her phone of the activity. Possible suspect vehicle seen was a black SUV with special rims.
