

<b>April 21, 2019 thru April 27, 2019</b>	<b>Calls for Service 404</b>	<b>Residential Burglaries 1</b>
<b>Total Year to Date for 2019</b>	<b>9,135</b>	<b>20</b>

For the period of Sunday, April 21, 2019, through Saturday, April 27, 2019, the Police Department responded to 404 calls for service. One residential burglary and No attempt residential burglaries occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.

**Sunday, April 21, 2019**

**4:09 P.M. – PC 242 / BATTERY / HUNTINGTON DRIVE:** SMPD Officers Responded to the location and conducted an investigation.

**11:35 P.M. - PC 484 / PETTY THEFT / ST. ALBANS & MILL:** Victim came into the SMPD lobby to report the above regarding a missing cell phone.

**8:31 A.M. – 902T / NON-INJURY / TRAFFIC COLLISION / HUNTINGTON DRIVE & PALOMAR:** PI was driving W/B on Huntington Drive and failed to stop for vehicles stopped at the crosswalk at Palomar Road, colliding into the rear of P2.

**4:32 P.M. – 901T / INJURY / TRAFFIC COLLISION / 2400 BLOCK HUNTINGTON DRIVE:** SMPD Officer was dispatched to a non-injury traffic collision at 1632hrs. Officer arrived and contacted the three involved parties. It was determined three vehicles were involved in a minor rear-end collision. One of the parties complained of leg pain but refused medical treatment. All three vehicles were driven from the scene.

**Friday, April 26, 2019**

**8:59 A.M. – BICYCLE UPSET / 1400 BLOCK VAN DYKE ROAD:** SMPD Officer arrived at the location to speak with the resident about an incident which occurred yesterday. The Reporting party stated he was riding his bicycle around 2030hrs and rode over a bump in the asphalt which caused him to fall off his bicycle. He sustained multiple abrasions to his torso, arms, and legs. He refused medical treatment. Photographs were taken of the area and of the reporting party. Street Department was notified regarding the street condition.

**4:06 P.M. – PC 459 / RESIDENTIAL BURGLARY / 1100 BLOCK LORAIN ROAD:** SMPD Officers arrived at the location for a burglary which had just occurred. SMPD Officers contacted the

victim. Victim said she left her residence today at approximately 1400hrs and returned at. Victim went inside and noticed multiple rooms were ransacked. She called her daughter to let her know what happened. As her daughter was walking into the above location, she noticed two suspects running to two different vehicles parked on Sherwood Road. One of the suspects got into the driver seat of a black Prius (NFD) and the other suspect got into a tan or caramel Prius. Both vehicles conducted a u-turn and fled eastbound on Lorain Road. The suspects could only be described as wearing dark clothing with hooded sweat shirts.

**5:43 P.M. – PC 647(f) / PUBLIC INTOXICATION / PC 148 / RESIST OFFICERS / 2200 BLOCK HUNTINGTON DRIVE:** SMPD Officers arrived at the location for a subject drinking alcohol inside a vehicle. The vehicle was described as a silver Nissan, unknown license plate. Upon arrival, SMPD Officers observed a female subject, Melinda Naomi Peck (Washington), (60), outside of a silver Nissan. S/Melinda was leaning into the rear passenger side door. S/Melinda noticed the SMPD Officers and quickly shut her vehicle door and started to walk away. S/Melinda appeared to be having difficulty walking. She was ordered to stop but she refused. SMPD Officer confronted her and again ordered her to stop. She attempted to walk around the officer at which time the officer held her arm preventing her from walking away. While speaking with S/Melinda, she appeared extremely intoxicated. Two empty vodka bottles were located inside S/Melinda's vehicle, near the driver seat. While speaking with Melinda, she continued attempting to walk away and not cooperate with SMPD officers. SMPD Officers attempted to place handcuffs on Melinda for public intoxication but she resisted. A minor use of force occurred and she was arrested. She was transported to the Alhambra Jail for booking without incident. Commander Ward was notified. She will be issued an O/R citation by night shift. Her vehicle was left parked on scene.

**4:12 P.M. - CV2 20002(a) / NON-INJURY / HIT-AND-RUN / HUNTINGTON DRIVE & LOS ROBLES AVE:** SMPD officers arrived at the above intersection regarding a non-injury, hit-and-run investigation. Victim was traveling westbound on Huntington Drive in lane #3. While approaching the intersection, a white Kia sedan passed victim along the right shoulder and sideswiped the passenger side of the victim's vehicle. After the collision, the suspect vehicle made a right turn onto northbound Los Robles Avenue. The vehicle did not stop and drove through a red light (at Wilson Avenue) and a stop sign (Winthrop Road). The victim followed the Kia onto La Mirada Avenue. As the suspect vehicle turned around, the victim took a photo of the vehicle. The license plate for the Kia returned to an address in the unincorporated area of Covina. The victim said the vehicle was occupied by a male passenger and female driver, however they would not be able to identify the driver. LASD San Dimas station was contacted to drive by the registered owners residence The LASD dispatcher advised the same vehicle was seen driving recklessly in the morning but was not found. Deputies were dispatched to the location and the suspect vehicle was not found at the location.
