Total Year to Date for 2019	9,677	22

For the period of Sunday, April 28, 2019, through Saturday, May 4, 2019, the Police Department responded to 542 calls for service. Two residential burglaries and No attempt residential burglaries occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.

Sunday, April 28, 2019

Monday, April 29, 2019

8:12 A.M. – FALSE PLATES / VEHICLE STORAGE / KENILWORTH & HUNTINGTON DRIVE: SMPD Officers observed a vehicle parked adjacent to the above location on Kenilworth just south of Huntington. The vehicle (Chevy Silverado Truck) had Nevada Temporary plates issued to a 2018 Chevy Impala. SMPD Officers contacted the RO who stated he was behind in payments to register his vehicle and put the fake plates on temporarily. Vehicle was stored.

10:18 A.M. – PC 594 / VANDALISM / 2900 BLOCK HUNTINGTON DRIVE: SMPD Officers arrived to the above location for vandalism. Officers contacted the property manager (Victim). Victim showed officers a window, back door, and inside an elevator that had spray paint graffiti with the letters “JC!”.

10:29 A.M. – VC 10851 / VC 20002 / HIT AND RUN / MONTEREY ROAD & SHENANDOAH: Witnesses called and reported observing a solo vehicle collision that had just occurred into a light pole and rolled over. While in route, the witness stated the driver exited the vehicle and fled on foot to the rear yard of a house in the 1600 block of Shenandoah. A perimeter was set around Shenandoah and Virginia Road. S/Martin, Paul Lee PJ was taken into custody in the side yard of 1600 Block of Virginia Road. Property from S/Martin was located in two yards of Virginia Road. The vehicle was reported stolen out of LAPD. S/Martin was also found in possession of a counterfeit US Postal arrow key. Postal Inspectors were notified. S/Martin was taken to a local Hospital for injuries occurred during the collision. He was issued an OR citation on the above charges while at the hospital. The vehicle was impounded.

1:19 P.M. – PC 484 / PETTY THEFT / 2900 BLOCK DUARTE ROAD: Victim came into the police lobby and reported someone had removed items from her vehicle. Victim stated she was at a friend’s house on 4/28/19 between 1300 and 1600 hours. When she returned to her vehicle at 1600 hours she saw the rear window to her vehicle was down. Victim does not believe her or her child lowered the window but did not know for sure. Items taken were a backpack containing some books and a karate uniform.

7:50 P.M. - FOUND PROPERTY / 1600 BLOCK VIRGINIA ROAD / SUPPLEMENTAL REPORT: SMPD Officers were dispatched to the above address reference to a report of found property. Officer arrived at the above location and contacted the RP. The RP stated she found a small zippered bag

in her back yard that did not belong to anyone in the house. SMPD Officer took possession of the bag and checked the contents. Inside the bag was a small zip lock baggy containing a crystalline substance resembling methamphetamine, a small zip lock baggy containing a white powdery substance resembling powder cocaine, a small zip lock baggy containing a black tar like substance resembling black tar heroin, and a “carved” key with black electrical tape wrapped around it. SMPD Officer took the contents to the station and booked them into evidence.

9:06 P.M. - P.C. 602(L) / TRESPASS / 1900 BLOCK EUCLID AVENUE: SMPD Officers arrived at the above address reference a report of three subjects in the rear yard. Pasadena air unit, PDI and South Pasadena PD were notified and responded. The SMPD Officers checked the property. No subjects were located. An SMPD Officer contacted the RP. The RP stated she was inside her house when her Ring doorbell activated for her rear yard. She went upstairs to a window and saw three subjects, wearing hooded sweatshirts, in her backyard. She yelled at them and told them she was calling the police. The three subjects ran to the front yard and northbound on Euclid Avenue, out of sight. A check of the area for the three subjects met with negative results. The incident was captured on surveillance video.

Tuesday, April 30, 2019

9:47 A.M. – PC 484G / FRAUDULENT USE OF ACCESS CARD / 1500 BLOCK WEMBLEY: Victim reported she found a statement from her Saks Fifth Avenue account in the mail. The account had been used in San Francisco. The victim did not give anyone permission to use her card and she had her card in her possession.

10:53 A.M. – PC 459, BURGLARY TO A VEHICLE / 1500 BLOCK WILSON: The SMPD Officers were responding to a suspicious person in the area of El Molino Place. A second person called and reported the same person walking up and down driveways in the Granada Avenue area. The SMPD Officers arrived on scene and observed a construction worker chasing the suspect down the street. The SMPD Officers contacted the suspect and saw him throw a nail gun into the bushes. The construction worker observed the suspect break into his truck tool box and remove the item and flee. Suspect was transported to Alhambra Jail for booking and housing.

CRI9-0369 – CANCELLED.

4:35 P.M. – PC 484 / PACKAGE THEFT / 1800 BLOCK ROSE AVENUE: S/Zhang reported a package was delivered by FedEx on 04/30/19 at 1331 hours. When he went to retrieve the package a few moments later it was missing. SMPD Officers did door knocks and was able to retrieve video from a neighboring house. The video from that house showed S/Zhang retrieving the package from the porch. S/Zhang called the station approximately 30 minutes later asking to cancel the report. S/Zhang was asked to the station to answer additional questions, which he did. S/Zhang arrived at the station and was confronted with the information regarding the video. S/Zhang admitted to filing a false police report. S/Zhang was issued an OR cite and released.

Wednesday, May 1, 2019

1:28 A.M. - P.C. 25850(a) / POSSESSION OF FIREARM / C.V.C. 23152(f) / DUI OF ANY DRUG / B&P 4060 / POSSESSION OF CONTROLLED SUBSTANCE W/O PRESCRIPTION / 1700 BLOCK HUNTINGTON DRIVE / IN CUSTODY. An SMPD Officer conducted a traffic enforcement stop for a vehicle code violation in front of the above address. The SMPD Officer contacted the driver, S/ Erik Wade Woods (27) of Lancaster, and noticed a gun holster on his hip. Woods admitted to having a gun in the driver’s side door pocket. S/Woods gave permission to search his vehicle and Officer

found prescription medication in a plastic baggy. S/Woods stated he bought the pills in Los Angeles. A field sobriety test was SFST performed and Woods failed the test. S/Woods was transported to Alhambra jail for booking and later transported to LASD for housing. S/Woods' vehicle (rental) was left legally parked in front of 1700 Block Huntington Drive.

10:13 A.M. – PC 530.5 / IDENTITY THEFT / 2300 BLOCK BRENTFORD: Unknown suspects accessed victim's 401K account. Someone accessed her account and attempted to have the money wired to the suspect's account. The suspects provided the bank two accounts to have money transferred. The bank did not transfer any money but sent the victim a check from her 401k instead. No Loss at this time.

12:00 P.M. – DEATH NOTIFICATION / 1100 BLOCK LORAIN: The SMPD was asked by Ventura County Sheriffs to do a death notification.

9:30 A.M. – 459 RESIDENTIAL BURGLARY / 1500 BLOCK CHARLTON: San Marino PD Officers were dispatched to a residential burglary from yesterday. Between the hours of 0730 hours and 2020 hours, an unknown suspect accessed the side door to the garage and removed a men's hybrid style bike. The victim was not able to provide further details on the color or make of the bike. Several boxes were looked through by the possible suspect but nothing else was missing. Unknown suspect left an umbrella and a pair of slippers behind. They were collected for evidence.

Thursday, May 2, 2019

10:12 A.M. - 902T / NON-INJURY/ TRAFFIC COLLISION / WINSTON & ROBLES AVENUES: The P2 was stopped for the stop sign at the intersection of Winston and Robles Avenues. PI was not paying to stopped traffic when vehicle collided into the rear of P2's vehicle causing minor damage to the bumper. Both vehicles were driven from the scene.

Friday, May 3, 2019

2:22 A.M. - PC 594 – VANDALISM / 600 BLOCK ALEGRIA PLACE: On 05/03/19 at approximately 0222 hours, officers were dispatched to the above location regarding a vandalism which occurred approximately 10 minutes earlier. Upon arrival, Victim, stated he woke up to the sound of two loud noises to the front of his property. He got out of bed and turned on the interior lights and found the front door window to be shattered. The victim found a hexagram nut on the front porch, which was not there prior to him going to bed. The residence is near the end of a remodel and the construction fence is still around the front. The victim advised of a dispute with the neighbor regarding the planting of privacy hedges. It is unknown if the dispute is related to the broken front window. Value of the front door is approximately \$1,800. Officers were unable to contact neighbors due to the late hour.

8:31 A.M. - WARRANT ARREST / CVC 14601.1(a) / DRIVE ON SUSPENDED LICENSE / KENILWORTH & HUNTINGTON DRIVE: SMPD officers initiated a traffic enforcement stop on a Kia Sportage SUV for CVC 22350. During the subsequent investigation, it was determined that the driver, Ashley Gibson (from San Bernardino) was driving on a suspended license. During a want/warrant check, S/Gibson returned with an outstanding warrant for \$15,000 out of the Pomona Police Department for 14601.1(a). Pomona PD was contacted and requested she be O/R released on a citation on their behalf. She was issued a second citation or CVC 14601.1(a). S/Gibson was released without further incident and her vehicle was driven from the scene by a licensed driver.

9:28 P.M. - 902T – INJURY TRAFFIC COLLISION / 1100 BLOCK HUNTINGTON DRIVE: PI was travelling in the #2 lane of Huntington Drive E/B. PI observed a metallic object fall off of the vehicle

in front of her. P1 slowed down in the #2 lane to avoid striking the object. P2 was travelling in the #2 lane of Huntington Drive E/B and observed P1 come to a complete stop in the #2 lane. P2 attempted to avoid striking P1 by turning into the #3 lane and struck the right rear of P1. P1 drove away from the scene and P2's vehicle was towed from the scene.

Saturday, May 4, 2019

3:39 A.M. - INCIDENT REPORT / 1700 BLOCK HUNTINGTON DRIVE: The report will be forwarded to the Pasadena Police Department for further action.

8:42 A.M. - PC 459 / RESIDENTIAL BURGLARY / 2100 BLOCK VALENTINE PLACE: The SMPD officers were dispatched to the above location regarding a residential burglary investigation. An unknown suspect entered the construction site through an unsecured fence surrounding the construction site. The unknown suspect(s) entered the residence through an open garage and removed three bi-folding doors. The crime occurred between 4/30/2019 1700 hours to 5/2/2019 0800 hours. No security camera were found in the immediate area.

9:54 A.M. - PC 532 / THEFT BY FALSE PRETENSES / PC 470d / FORGERY / PC 530.5 / IDENTITY THEFT / 2100 BLOCK LORAIN ROAD: Victim came to the SMPD lobby to report he was the victim of a crime. While using the internet, a message appeared on victim's computer screen advising him that a virus was detected. He contacted the phone number on the message and spoke to a technician who would be able to "fix" the problem. Victim allowed the technician to remotely access his computer. Later victim gave the technician his bank account number and routing number in order to "pay" for the repairs. Victim later re-contacted the company that fixed his computer and asked for a refund since it appeared nothing was "repaired" on his computer. The technician told victim that he would provide a "refund" of the charges for the "repair". During the "refund" process the technician claimed that Lee entered the refund amount incorrectly through their payment portal. The technician requested victim pay back the money in Best Buy gift cards. Victim agreed and purchased the cards at a local Best Buy store and gave the gift card numbers to the technician. A few days later victim felt that it appeared to be a scam and attempted to cancel the cards, however Best Buy told him that the cards were already used in a store in New York. Later while checking his bank accounts, victim also discovered that a fictitious check was cashed. The check had victim's personal and bank account information on it.

10:19 A.M. - PC 530.5 / IDENTITY THEFT / 2400 BLOCK CUMBERLAND ROAD: At 1019 hours, the Victim came to SMPD lobby to report he was the victim of identity theft. On 04/30/2019, he received a voice message from "Social Security" notifying him there were several fraud claims using his social security number. He called the phone number back and contacted someone who identified himself as an employee of "Social Security". The victim believing that the employee was legitimate, provided his personal information to the caller. The employee said he would call the victim back later regarding the investigation however he did not received a return phone call. He contacted the Alhambra office of the Social Security Administration who advised him that it was a scam. He came to the SMPD to report the crime.
