

April 7, 2019 thru April 13, 2019	Calls for Service 517	Residential Burglaries 2
Total Year to Date for 2019	8,214	18

For the period of Sunday, April 7, 2019, through Saturday, April 13, 2019, the Police Department responded to 517 calls for service. Two residential burglaries and No attempt residential burglaries occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.

Sunday, April 7, 2019

3:42 P.M. - INCIDENT REPORT / DOG BITE / 2400 BLOCK RIDGEWAY: SMPD Officers contacted victim who stated he was walking his dog when a German Shepard and a smaller white dog attacked his dog, causing a small puncture wound to the his dog's back. SMPD Officers located the dogs on Coniston Place. Both dogs were friendly to people but the German Shepard became aggressive when another dog was walking by. Animal Control and PD were able to get both dogs in custody. SMPD Officers located the home owner, by dogs chip, to 2400 Block Ridgeway. SMPD Officers made contact with the caretaker at the house. The homeowner asked Animal Control to seize both dogs, which they did. As officers were at the scene, separate residents complained about the dogs being loose daily.

7:08 P.M. - FOUND PROPERTY / 2200 BLOCK HUNTINGTON DRIVE: SMPD Officer was flagged down by the RP who stated he found an IPAD in the parkway. SMPD Officer took possession of the IPAD and booked it into found property. The IPAD was placed into APS.

Monday, April 8, 2019

6:48 A.M. - INCIDENT REPORT / VEHICLE STORAGE 22651(o)(1)b/SIERRA MADRE & CANTERBURY ROAD: SMPD Officer conducted a traffic stop and found the vehicle license plate had a false tab. The driver, was not the RO of the vehicle and denied knowing anything about the license plate tab. The vehicle was stored.

10:24 A.M. – IDENTITY THEFT / PC 530.5 / 1100 BLOCK OAKWOOD: Victim reported unknown suspect(s) used his personal information and ordered several pairs of Ray Ban sunglasses. The sunglasses were delivered to the above location. This is the second package the victim has received by the same means and same circumstance (CR18-0319).

11:03 A.M. – PC 487 / GRAND THEFT / 2000 BLOCK HUNTINGTON DRIVE: Victim stated unknown suspect(s) entered her safe deposit box and took her property. The last time she remembers seeing the property was in November of 2018, even though she has been in the safe deposit box several times since then. Victim is the only person who has access to the safe deposit box.

8:01 P.M. - OSJ / WARRANT/ ARREST / 1400 BLOCK SAN MARINO AVENUE: SMPD Officer conducted a traffic enforcement stop for a vehicle code violation and contacted the driver, S/ Jermaine Smith. A records check of S/Smith returned with an active warrant, in the amount of \$20,000 for

14601.1(a) VC, out of Alhambra PD. S/Smith was arrested and transported to the Alhambra jail, per Alhambra PD request. S/Smith's vehicle was left legally parked on San Marino Avenue.

11:45 P.M. - C.V.C. 22651(O) / EXPIRED OVER 6 MONTHS / VEHICLE STORAGE & SANTA ANITA & CANTERBURY: SMPD Officer conducted a traffic enforcement stop for a vehicle code violation. A records check of the vehicle revealed the registration was expired for over six months. The vehicle was stored.

Tuesday, April 9, 2019

12:13 P.M. – NON-INJURY / 902T / TRAFFIC COLLISION / SAN MARINO & LORAIN: P1 and P2 were involved in a minor traffic collision in the intersection of San Marino and Lorain. Both had conflicting statements and no primary collision factor was able to be determined.

4:11 P.M. – PC 459 / RESIDENTIAL BURGLARY / AVONDALE ROAD: Pulled by Detectives.

5:23 P.M. - APS REPORT/ 2700 BLOCK HUNTINGTON DRIVE: SMPD received an APS report stating Victim is not being cared for by his wife. Report claims victim is elderly and keeps getting out of the house and wondering. Both parties are elderly. There is no crime or danger to either victim or his wife. APS was contacted and they are sending out a Social Worker in the morning to evaluate. APS has been working with the family for several months.

Wednesday, April 10, 2019

2:24 P.M. – PROPERTY FOR DESTRUCTION / 2900 BLOCK HUNTINGTON DRIVE: RP came into the lobby to turn in a firearm for destruction. SMPD Officer took custody of a Burgo .22 caliber revolver belonging to his client's deceased father. The firearm was booked evidence and entered into AFS.

2:43 P.M. – CVC 22651(h)(1)/VEHICLE STORAGE / HUNTINGTON DRIVE & WINSTON; S/HA, Robert (San Diego), (35) was stopped for a traffic violation. S/HA was found to have an outstanding misdemeanor warrant out of CHP in the amount of \$35,000 for CVC 14601.1(a). CHP responded and took S/HA into custody. His vehicle was stored.

5:37 P.M. – CVC 20002(a)/HIT AND RUN / HUNTINGTON & OAK KNOLL: Victim advised he was hit by Black Chevrolet Impala. He was following the vehicle N/B on Oxford Rd. near the Huntington Library and lost sight. SMPD Officers checked the area and did not locate the suspect vehicle. The collision occurred in the area of E/B Huntington Dr. and Oak Knoll Ave.

6:53 P.M. - VEHICLE STORAGE / SIERRA MADRE & CALIFORNIA: Vehicle was stopped for a vehicle code violation. Vehicle stored for registration expired over 6 months.

Thursday, April 11, 2019

7:52 P.M. - PC 484(a) / 2700 BLOCK HUNTINGTON DRIVE: RP contacted the San Marino Police Department and advised his bicycle was stolen from the bicycle rack at the above location. RP stated he parked and locked his bicycle in the bicycle rack at approximately 0750 hours on 04/10/19. RP returned to the bicycle rack at approximately 1845 hours and discovered his bicycle missing. The RP's bicycle lock was locked around the bicycle rack and his helmet was on the ground. The bicycle was entered into APS as stolen.

Friday, April 12, 2019

5:41 A.M. - BARKING DOG / 2000 BLOCK SAN MARINO AVENUE: RP contacted the San Marino Police Department and advised his neighbor's dog was barking for approximately 40 minutes. SMPD Officer arrived on scene and began the observation period and found the dog to be barking continuously for 10 out 15 minutes. This is the first confirmed violation in a 30 day period.

11:51 A.M. - PC 647(i) / PROWLING / 2400 BLOCK MONTEREY ROAD: SMPD Officers were dispatched to the location for a burglary in progress. SMPD Officers arrived on scene and contacted the resident who stated he noticed two men in his backyard walking towards the rear door. The two suspects noticed the resident and ran towards the driveway, jumped over a three-foot fence and entered a red vehicle. A neighbor stated he saw three males running from resident's rear yard and got into a faded red sedan. The vehicle fled northbound on Euclid and out of sight. The suspects were not able to attempt access into the residence before running away. The suspects were only described as wearing dark clothing and masks. The vehicle appeared to have a California license plate but the numbers were not seen. Detective responded and searched for cameras.

3:34 P.M. – CVC 22651(o)(1) / Vehicle Storage / 1800 BLOCK EUCLID AVENUE: SMPD Cadet located a vehicle with expired vehicle registration (10/2018). Vehicle was stored.

12:57 P.M. – Incident Report / 1800 BLOCK HUTNINGTON DRIVE: SMPD Officer arrived to the above location for an investigation. At the time of this report, we were not able to contact any witnesses directly or the male subject. Officer will attempt to contact tomorrow.

5:03 P.M. – CITY PROPERTY DAMAGE /SIERRA MADRE & WALNUT: While in Pasadena on City business, an SMPD Cadet rear ended another vehicle. . The vehicle sustained moderate front end damage. No one was injured in the collision. Pasadena PD responded and completed the investigation and report.

5:35 P.M. – PC 470 / FORGERY / 1200 BLOCK MILL LANE: SMPD Officer arrived at the station lobby for a possible identity theft investigation. SMPD Officer contacted the victim. Victim stated he discovered three forged checks. Victim said two of the checks appeared to be stolen and the other one was written to an employee and changed.

7:12 P.M. - PC 459 / RESIDENTIAL BURGLARY / 1300 BLOCK OAK GROVE AVENUE: SMPD received a call regarding a possible burglary which just occurred. While responding to the location, the RP advised the incident may have occurred approximately 2 hours prior to the call. Upon arrival, SMPD Officers conducted an interior check of the property and found no outstanding suspects inside. While conducting the interior check, multiple rooms appeared to be ransacked.

A Pasadena Crime Technician arrived on scene and completed their investigation Victim advised his wife left the location at approximately 1200 hours. Victim's housekeeper arrived at the location at approximately 1730 hours and discovered a broken window pane at approximately 1900 hours. Victim was unsure if his alarm was set at the time of the crime. At the time of the report, a revolver was the only item stolen from the location. The firearm was listed as stolen in the Automated Firearm System. A canvas of the area for cameras showed two houses with cameras. There was no answer at one house and the residents were unsure of how to review the footage at the second house.
