For the period of Sunday, February 2, 2020 through Saturday, February 8, 2020, the Police Department responded to 552 calls for service. Two residential burglaries, zero commercial burglary, and one attempt residential burglary occurred during the reporting week. The following is a summary report of the key incidents handled by the Department during this reporting period.
